A Campaign Registration Statement and a Declaration of Candidacy, must be filed no later than 5:00 p.m., on Tuesday, January 4, 2022 in the office of the applicable clerk.

If nomination papers are required, the first day to circulate nomination papers is December 1, 2021, and the final day for filing nomination papers is 5:00 p.m. on Tuesday, January 4, 2022.

Judicial office candidates file with the Wisconsin Elections Commission. County Board Supervisor candidates file with the County Clerk. Municipal candidates file with the Municipal Clerk. School District candidates file with the School District Clerk.

#### Primary Election

If a primary is necessary, the primary will be held on Tuesday, February 15, 2022.

#### Additional Information

Acceptable Photo ID will be required to vote at this election. If you do not have a photo ID, you may obtain a free ID for voting from the Division of Motor Vehicles.
